CSI PA Railroad Chapter and AIA Middle PA Chapter Hold Joint Meeting

Armstrong Ceilings Conducts Sustainable Ceiling Presentation



The Greater Pa Carpenters Central Campus in Duncansville PA was the site of the Sustainable Ceiling Systems presentation given by Armstrong Commercial Ceiling Systems on August 7, 2012. Here, Stacy Jordan of Armstrong provided an AIA continuing education unit presentation geared towards sustainable ceilings.

Stacy explained to members of the PA Middle Chapter and the CSI PA Railroad Chapter how ceiling systems can contribute to sustainable design and potentially earn points in the LEED rat-

ing system. The building areas affected are energy performance, indoor environmental quality, and selection and use of environmentally friendly materials to make up the ceiling systems.

Case studies were presented using various designs and material types selected that showed the

impact of sustainable design on energy usage and environmental sustainability. These cases covered offices, food stores, schools, and healthcare facilities. Clear indication was given in each of the case studies showing the savings to the owner due to less energy usage, higher sales for stores, and better health for occupants.

Also included in the presentation was a review of the first green convention center in the world – the David L. Lawrence Convention Center in Pittsburgh, PA. The review covered how the Center uses day lighting as a primary light source due to the ceiling reflectance elements that allow this to be achieved.

After the continuing ed presentation was completed, Steve Fischer of Armstong did a hands-on demonstration of Armstrong ceiling systems that were constructed and on display in the Center.

The advantages of each of the types and elements of the sustainable Armstrong ceiling systems that were displayed was explained by Steve. Cost saving Axiom lineal system and its elements along with other ceiling system elements, such as the Armstrong "strongback", were explained and shown to participants.

As of last week's U.S. Green Building Council (USGBC) board meeting, Green Building Alliance is now officially a designated chapter of the national organization. Because GBA was founded before USGBC, it was designated as an Affiliate when the two organizations started working together. By shifting to the chapter designation, GBA joins a community of 78 other local chapters across the country.

So what will change? Not much. All of our activities, events, programs, membership, board representation, and fundraising efforts will remain the same. As a USGBC chapter, however, we will gain access to additional grant funding and more formally coordinated efforts with the national leadership. Wisconsin's Green Building Alliance – the final remaining affiliate organization— is expected to be approved as a chapter at the next USGBC board meeting.

As we approach our 20th year as a regional catalyst for the creation of healthy and high-performing buildings, GBA's board and staff members are looking forward to the next 20 years of success and leadership under this new designation.

It is a two year term and the roles and responsibilities include:


- Attend the five Board of Directors meetings (mix of in-person and teleconference)


Additional Details:


- You must be a graduate of an architecture school (not a current student)

- There is a budget for your participation in the activities listed above.


