

GOOD OF THE ORDER

It happened yet again. Another terrible incident that drives home the importance of holding dear to us our No. 1 goal, protecting the health, safety and welfare of the building occupants. The Ghost Ship's horrible fire in Oakland CA claimed 36 lives due to the failure of the building to live up to following Code. The building was not big by Oakland's commercial building standards, 10,000 square feet but big enough to pack in 50 – 100 people on the second floor – a second floor that had two stairs, both leading to the first floor. They gave no direct access to the outside. Neither were constructed per Code. Thirty six people lost their lives on Dec 2, 2016. How this building flew under the radar will probably be investigated for a long time. Holding dear our No. 1 goal is ever so important.




