Annual Joint Meeting of AIA / ASHRAE

John Gach Presents "LED's — Bridging Technology for Outdoor Applications

The annual AIA Middle PA Chapter and ASHRAE meeting was held at Jethro's in Altoona. Dave Macharola, President of the AIA Middle Chapter introduced Dave Anderson, Vice President of ASHRAE, Johnstown Chapter, Tom Columbus Jr., Vice President of AIA Middle Chapter, and Dan Spinazzola of Hite Electric. The introductions were followed by a buffet dinner.

Dave then introduced the guest speaker for the evening, Mr. John Gach, Regional Sales Manager – Advanced Technologies of Cooper Electric. The presentation began with an overview of the tremendous strides being made in the LED commercial lighting industry — the real future of

lighting. Mr. Gach discussed the advantages of using LED vs. MH systems regarding environmental impacts. The Department of Energy, over the next ten years, wants to reduce this impact by 1/4 of the energy consumed. An interesting fact that John told the group that one gallon of gas converts to 20 lbs. Of CO₂ released into the atmosphere. To spur this reduction, the DOE awarded grants totally \$150 million in 2010 to various companies to research LED lighting both indoors and outdoors. In the near future, we will in all probability not be talking about watts for light bulbs but lumens. The United States is in the process of getting rid of incandescent bulbs which much of the rest of the world has already done. He passed around several examples of LED lighting in different applica-

tions.

Mr. Gach discussed the advances in the manufacture of the LED crystals such as texturizing the LED chip to get more lumens out of the LED in order to achieve Target Zone Efficacy — getting the light to exactly where you want it.

The bottom line of the presentation was Mr. Gach's final thought: "Environmental Sustainability . . . save money and helps the environment"!

Comments on the Profession of Architecture by Tom Columbus Jr., AIA, LEED AP

Code Interpretation

In theory, the thought of all projects being designed under the same Code (International Code Council's family of Codes) and adhering to the same regulations, sounds like a dream come true to architects. However, in networking with other members of our Middle Chapter, and those in our allied fields, a common thread has surfaced. This common denominator is that interpretation of this same Code by various Code Enforcement personnel and agencies may vary. Another complication for A/E personnel licensed in various States, is that each State adds regulations to the base Code. These in turn can cause various interpretations. Lesson learned: Make friends with your project's Code Enforcement Officer early on. Informal discussions also help by preparing the officer for review of your project and saving you time by not having to do resubmittals.


