

Exploration of Dual Campus Environs Discussed

Dickinson School of Law Topic of Lecture Series



Dickinson School of Law Building Pennsylvania State University Main Campus Polshek Partnership Architects

In a rare opportunity, the Middle Chapter's membership was treated to an extremely interesting discussion of an unusual project. Tim Hartung of the Polshek Partnership illuminated the complicated but interesting study of the coevolution of both the Carlisle and University Park Campuses of the Dickinson School of Law.

During his introduction, Mr. Hartung gave a brief snapshot of his firm and recently completely projects. A diversified staff, Polshek Partnership consists of members from 34 states and 10 countries with 35% of the employees women and 29% minorities. There are 9 partners, and the firm is headquartered in New York City. Recent projects include the Clinton Presidential Library, Holland Performing Arts in Omaha, Nebraska, the New York Botanical Building and

the Cornell Care Facility located in New York City.

The Dickinson project started in the Fall of 2005. The initial premise was to find a relationship between the two campuses. Because both will be contributing to the local communities, they were evaluated for environmental effects — wind, solar, site entry, views — and how best to relate the new campus to each situation. Common elements for both were evaluated as well as "zones of influence". A major consideration at the Carlisle Campus was how to handle Trickett Hall — should it be retained and, if so, how to integrate this landmark with the new building. Hypothetical site responses were done resulting in the University Park building designed as a gateway to the campus. Public outcry against the possible removal of Trickett Hall and more questions resulted in suspension of work on the Carlisle Campus.

Mr. Hartung continued his discussion on the design of the University Park building covering topics such as the building program, in which the Library would occupy 50% of the floor plan, and materials selection. These building materials included Pennsylvania limestone as well as zinc panels for an exterior finish. However, after further investigation, an all glass building gained favor and the final design was completed. It is important to note that this design included sustainability elements, an important consideration for this project.

Construction of the Dickinson Law School Building on the University Park Campus is scheduled to begin in December, 2006 with completion scheduled for January, 2009.

I believe AIA Middle PA knows where it is going in 2007 thanks to the all the generous and talented people that have volunteered to get involved and serve our mission. In place already is the lecture series at PSU SALA building which is a great opportunity to visit the educational environment of today's students. This year we would also like to reach out to students from Penn College in Williamsport. Penn College has graciously accepted to host a Chapter meeting enabling members and affiliates around that area to attend a meeting more conveniently. The date still needs to be determined.

Lastly, there are three New Year suggestions for getting involved in 2007: 1) If you missed the Pennsylvania Builds 2006: A Regional Design Showcase of New Buildings, there will be opportunity to submit for the 2007 issue. The publication is a joint effort of Pennsylvania Business Central and the AIA Middle PA planned to promote architectural design accomplishments in our region. 2) Make a Political Action Committee (PAC) Contribution/ Pledge for 2007. AIA PA estimates that if every registered architect member of AIA Pennsylvania gave just \$25 the PA PAC would have close to \$50,000 to support the preservation of the Architectural Profession. 3) Contribute an article for the newsletter. 

FORENSIC ARCHITECTURE

LARGE ROLL TOILET PAPER DISPENSER MOUNTING HEIGHT LOCATION:

This edition's article is a request. If any reader is able to provide another solution to solve this problem we all would like your help. Most times these days Owners are using vendor provided large roll toilet paper dispensers. These dispensers hold a large roll of paper that lasts longer saving housekeeping labor. Most times they are also mounted below the grab bar. This low discharge opening makes it impossible to see and hard to feel for the torn end of the paper. Probably in the interest of

uniformity the dispensers are also located too low in the non-accessible stalls. Recommend we show the location of the large roll toilet paper dispenser, even if it will be Owner furnished, so that they end up being more user-friendly. Following the ADA Guidelines the dispenser can be mounted with its paper source at a maximum height of 48" high above the finish floor. Recommend we show the bottom at 48" in all stalls so you can see the elusive end of the paper; rather than having to feel for it. At 48" the roll is high enough above grab bars to not interfere with paper use.
